Amendments or alterations shall be made in the purpose of the Association getting approval by 3/5 of the members preset at the executive committee meeting subject to the provisions stated in the societies registration act 1860, Central Act No. XXI of 1860 & XXXV of 2001.

Rule No. 20 Winding up Procedure:

In case the Association has to wind up, the property and funds of the Association that will remain after full satisfaction of the liabilities of the Association, will be transferred or paid to some other institution, having similar aims and objectives and registered u/s 12(A) and 80G of Income Tax act 1961 only. This will be determined by the votes of 3/5th of the members present personally or by proxy at the time of the dissolution of the Association, the detailed instructions contained in the relevant sections of the provisions of the societies Registration Act, 1860 Central Act No. XXI of 1860 & XXXV of 2001 shall applying all matters not expressly provided for in there rules.
